The purpose of the public hearing is to allow any person to be heard in favor of or against the proposed budget as it is submitted, or for or against any item or items contained in the proposed budget, and hearing all persons interested in the subject concerning same.

That a copy of the proposed budget is available at the Office of the Town Clerk of the Town of Vienna at 2083 State Rt. 49, North Bay, NY Where it may be inspected by any interested person during office hours on Monday, Wednesday, and Friday from 9:00 a. m. to 3:00 p. m., Tuesday from 9:00 a. m. to 4:00 p. m., and Thursday from 9:00 a. m. to 5:00 p. m. 

The attached Notice of Public Hearing on the Budget, at least once five days before the date specified for the hearing,


- 1) Was published in Queen Central Newspaper, the official newspaper of the Fire District on October 10, 2011;
