OF THE TOWN OF VIENNA
LOCAL LAW NO. 3 OF 1998
INCREASE LOCAL DOG LICENSE FEES TO \$4.00

WHEREAS, a resolution was duly adopted by the Town Board of the Town of Vienna for a public hearing to be held by said Town Board on July 22, 1998 at the Vienna Town Hall to hear all interested parties on a proposed Local Law entitled, "Local Law No. 3 of 1998" and

WHEREAS, notice of said public hearing was duly advertised in the Queen Central News, the official newspaper of the Town of Vienna on July 11, 1998, and

WHEREAS, said public hearing was duly held on July 22, 1998 at 8:00 p.m. at the Town of Vienna, Town Hall and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said Proposed Local Law, or any part thereof, and

WHEREAS, PURSUANT TO Part 617 of the implementing regulations pertaining to Article 8 (State Environmental quality Review Act) it has been determined by the Town Board that adoption of said proposed Local Law would not have a significant effect upon the environment and could be processed by other applicable governmental agencies without further regard to SEQR, and

WHEREAS, the Town Board of the Town of Vienna, after due deliberation, finds it in the best interest of the Town to adopt said Local Law,

NOW, THEREFORE, BE IT MOTIONED PASSED, that the Town Board of the Town of Vienna hereby adopts said Local Law No. 3 of 1998 entitled "Amendment of Local Law No. 1 of 1983" a copy of which is attached hereto and made a part of this resolution, and be it further,

RESOLVED, that the Town Clerk be and she hereby is directed to enter said Local Law in the minutes of this meeting and in the Local Law Book of the Town of Vienna, and to give due notice of the adoption of said local law to the Secretary of State of New York

Be it enacted as follows:

That a local fee of Four Dollars (\$4.00) shall be imposed for each dog license issued after the effective date hereon, such local fee to be in addition to fees set forth in S110 of the Agriculture and Markets Law.

Section 2 Kennel Licenses

The fee of One Dollar (\$1.00) will remain the same for kennel licenses.

Section 3 Use of Local Fee

Such Four Dollar (\$4.00) fee shall be the property of the Town of Vienna and the same be utilized by the Town for dog control in accordance with the provisions of Article 7 of the Agriculture and Markets Law.

Effective Date

This Local Law shall take effect upon filing with the Department of State.
